

THE CORPORATION OF THE TOWN OF AJAX

BY-LAW NUMBER 72-90

Being a by-law respecting the regulating and governing of Adult Entertainment Parlours.

NOW THEREFORE, the Council of the Corporation of the Town of Ajax enacts as follows:

I DEFINITIONS

1. (a) "Adult Entertainment Parlour" means any premises or part thereof in which is provided services appealing to or designed to appeal to, erotic or sexual appetites or inclinations.
- (b) "Attendant" means any person other than a licensed owner or operator who provides services designed to appeal to erotic or sexual appetites or inclinations at an adult entertainment parlour.
- (c) (i) "to provide" when used in relation to services includes to furnish, perform, solicit, or give such services in pursuance of a trade, calling, business or occupation and "providing" and "provision" have corresponding meanings.
(ii) "services" includes activities, facilities, performances, exhibitions, viewing and encounters.
(iii) "services designed to appeal to erotic or sexual appetites or inclinations" includes:
 - (a) services of which a principal feature or characteristic is the nudity or partial nudity of any person;
 - (b) services in respect of which the word "nude", "naked", "topless", "bottomless", "sexy" or any other word or any other picture, symbol or representation having like meaning or implication is used in any advertisement.
- (d) "Owner"
 - (i) When used in reference to an adult entertainment parlour means a person who alone or with others has the right to possess or occupy an adult entertainment parlour or actually does possess or occupy an adult entertainment parlour and includes a lessee of an adult entertainment parlour or of premises upon which an adult entertainment parlour is located.
- (e) "Operator"
 - (i) When used in reference to an adult entertainment parlour means a person who alone or with others operates, manages, supervises, runs or controls an adult entertainment parlour.

2. No person shall own or operate an Adult Entertainment Parlour in the Town of Ajax or provide services in an Adult Entertainment Parlour in the Town of Ajax, except in those areas designated in the attached Schedule "A" which shall form a part of this By-law
3. By-law Numbers 171-81, 5-82, 47-84, 3-86 and 151-87 be and the same are hereby repealed.

This By-law shall come into force and have effect from and after the final passing thereof.

READ a first time this Seventeenth day of April, 1990.

READ a second time this Seventeenth day of April, 1990.

READ a third time and finally passed this Seventeenth day of April, 1990.

SCHEDULE "A" TO BY-LAW #72-90

HIGHWAYS ON WHICH ADULT
ENTERTAINMENT PARLOURS
ARE PERMITTED

LOCATION ON HIGHWAY WHERE
ADULT ENTERTAINMENT PARLOURS
ARE PERMITTED

FULLER ROAD

North and east side, commencing at a point being 125 metres running south from its point of intersection with the east limit of Dreyer Dr. W. and extending to its point of intersection with the north limit of Clements Road.

MACKENZIE AVENUE

East side commencing at a point being 125 metres south of its intersection with the south limit of Bayly Street West and extending to its point of intersection with the north limit of Clements Road.

MCMASTER AVENUE

Both sides, commencing at the north limit and extending to the south limit.

FRANKCOM STREET

North side, commencing at the east limit of McMaster Avenue and extending to its east limit.

THOMSON STREET

North side, commencing at the intersection of Frankcom Street and extending to the west limit of Dowty Road.

FAIRALL STREET

North and south side commencing at its intersection with the east limit of McMaster Street and extending to its intersection with the west limit of Dowty Road.
